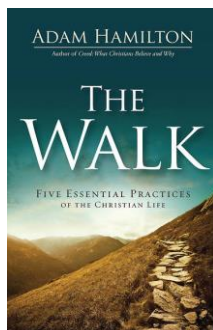

## ***The Annual Meeting of the Congregation of Our Savior's Lutheran Church will be held Sunday, February 6, 2022 at 11:30 A.M.***

Seventy-five voting members shall constitute a quorum. **Voting** members are confirmed members. The Church Council has recommended, and we will vote on the below constitution changes:

### **Personnel Committee Constitution Change:**

**Current: C13.04** A **Personnel Committee** of five members shall consist of the president, vice president, past president, and two members elected by the congregation. Term of office shall be three years and members shall serve no more than two terms consecutively.

**Change to: C13.04** A **Personnel Committee** of five members shall consist of the president, vice president, and three members elected by the congregation. Term of office shall be three years, with one member elected each year. Members shall serve no more than two terms consecutively.

### **Finance Committee Constitution Change:**

**Current: C13.06** A **Finance Committee**, of three members including the treasurer, a member of council and one member elected by this congregation. Terms of office shall be three years and members shall serve no more than two terms consecutively.

**Change to: C13.06** A **Finance Committee**, of five members including the treasurer, a member of council and three members elected by this congregation. Term of office shall be three years, with one member elected each year. Members shall serve no more than two terms consecutively.

Copies of the 2021 Congregational Annual Report will be available in the Social Hall and on our website by January 28, 2022. The Budget Meeting will be held on January 30, 2022.
